### **Discussion**

**Bruce Parks** - was asked about the Recall Sisolak movement. Because of the shut-down, their signature gathering is not going as well as they'd hoped. They need 250K signatures in 90 days (May 15) and they had 56 people working on gathering signatures. The Sec'y of State was asked about an extension in these difficult times and was told she doesn't have the authority to grant that, as it wasn't in the statute. The Governor can do that, but it isn't likely he'll extend to those trying to unseat him.

There are 3 recourses: 1) when this madness ends, EVERY body (like 300 of us) must work to get 30 signatures each, which would just about cover Washoe County. The other counties would still have to produce a similar effort proportionately; 2) A new Recall Sisolak effort could be mounted in October; 3) Elect ANYbody but Sisolak in 2022; 4) Elect more Republicans to the State Legislature in November 2020 so his power is diminished.

Bruce is also hosting an informational meeting on whether or not emergency declarations by local electeds are stripping us of our Constitutional rights.

**!!!Action Alert!!!** On Monday, April 13, Reno City Council will be holding a special meeting to address the concept of emergency ordinances pertaining to social distancing, as well as the creation of an Emergency Advisory Board. We need to write in comments ahead of time, so the Councilmembers will get a sense that we are unhappy about so much governmental intervention into our day-to-day lives. Here is what has been listed on the Council's Agenda for April 13:

B.1 Presentation, discussion, and potential direction to staff regarding the potential use of Emergency Medical Dispatch and the Reno Fire Department's emergency draw down plan related to the COVID-19 pandemic. (For Possible Action)

B.3 Presentation, discussion, and potential direction to staff regarding a potential emergency ordinance to implement social distancing and other guidelines in grocery stores. (For Possible Action)

B.4 Staff Report (For Possible Action): Resolution of the Reno City Council creating the City of Reno Public Health Emergency Advisory Board.

Concerned Citizens may call in, but they are (in likely violation of an Open Meeting Law) only put on record not played on record. Jeff suggests that you record it under 3 min on your Cell Phone voice recorder, then play that onto record to avoid mis-speaking. **(775) 393-4499**. Messages received will either be broadcast into the Council Chamber during the meeting, or transcribed for entry into the record.

Jeff also said his research shows that (thanks to the lawsuit formerly filed and won by Eddie Lorton) the Mayor has no authority whatsoever to issue edicts or binding decrees or orders of any kind. Authority to address emergencies rests

squarely on the City Council.

Furthermore, Jeff let us know about the exorbitant amount of overtime for the Fire Department. 252/hrs per day in overtime is allocated to fire fighters. That is \$5M in a year in overtime... \$\$ that could be better spent in so many other areas.

**All-Mail Ballot** - Secretary of State Barbara Cegavske has determined that Nevada will have an All-Mail Ballot for the June Primary.

*"Nevada plans to conduct an all-mail election for the June 9, 2020 primary election. All active registered voters in Nevada will be mailed an absentee ballot for the primary election. No action or steps, such as submitting an absentee ballot request application, will be required by individual voters in order to receive a ballot in the mail. Voters will be able to mark their ballot at home and then return it by mail using a postage-prepaid envelope or by dropping it off in person at a designated county location. This announcement applies only to the June 9, 2020 primary election."*

Jeff says this All-Mail ballot gives us a once-in-a-lifetime opportunity to urge the Registrars of Voters in the counties to see what ballots come back undeliverable, research if they voted in 2018, if they're still eligible to vote and remove them from the rolls if not.

**Terese Huerstel** - candidate for School Board At-Large, Dist A. Terese is a retired music teacher of 22 years. She personally is happy with the newly named Superintendent of Schools, Kristen McNeill, whom she has known since 1996. Kristen has been a teacher and Terese knows for a fact that the working environment changed for the better in the Administration Building when Kristen was named Interim Superintendent after Tracy Davis was fired. Terese's main campaign issue is teacher 'burnout'. As a teacher for many years, she felt first-hand, being unable to discipline students who violated rules or risk retribution from the Principal. When teachers can control the classroom (with the support of parents, admin and the students), they can teach.
