## **Discussion**

**Jeanne Herman** - Washoe County, the City of Reno and the City of Sparks are working together to bring forward a joint proposal for a new federal lands bill, the Truckee Meadows Public Lands Management Act. Jeanne is very OPPOSED to this bill, which will give away large portions of our prime land for development in exchange for giving us some BLM land, which will be forever earmarked as wilderness and closed to hiking, camping, backpacking, farming, grazing, mining, farming, birdwatching, hunting, wildlife preserves. Some ranches will be lost in the process. This mostly affects District 5 (Jeanne's district) and she was left out of the negotiations until recently. Over a million acres of multiple-use land will be closed to all and will revert back to the desolate desert it once was. Millions of dollars in revenue from agriculture, exploration for strategic minerals, recreation, hunting, and for military and tech maneuvers will be lost. **John Jorgensen** - Caucus vs Precinct Meetings. John thinks the State Party made a huge mistake and lost a lot of momentum by not having a Presidential Preference Poll Caucus this year and then telegraphing it to the media that the "Republican Party is not having a Caucus this year", which took great delight in airing that all over the place. In fact, it is prescribed in NV law that both major political parties have Precinct Meetings and a County Convention every 2 years and Precinct Meetings should have been the talking point - not "no Caucuses." GOAL - turn NV red; STRATEGY - get Rs and others to vote Republican; TACTIC - how we do strategy and we failed on the last point.

**John Eppolito** - A student at Bishop Minogue committed suicide last October, after having used the

one-on-one (1:1) electronic tablet devices in his school equipped with the app Kahoot. Within Kahoot, he took a survey/test called "Should I Kill Myself?" the night before he took his life. When John found out this app is also used by Washoe County School District, he went to the Board meeting yesterday and was told by Board President Malena Raymond that the app was determined last May, 2019 not to meet privacy standards and it was decided to remove it. However, it will take until July, 2020 to get it off the 1:1 devices in the students' hands. The Board doesn't even know what's in these apps and can't protect children, but worse, they won't let parents protect their own children by allowing opt-outs from using the devices.

**Sharron Angle** - Election Integrity Project Nevada (EIPNV) is part of EIPCa, which is a 501(3)c non-profit, non-partisan, tax-exempt, public benefit corporation. EIPCa has chronicled abuses in California, which have been taken to the courts by Judicial Watch and they have won victories, with counties such as Los Angeles, admitting wrong-doings by not removing deceased citizens from the voter rolls. EIPCa will be following up and making sure those counties do what they have promised.

EIPNV will follow the CA example and have folks manning polling places - indoors and out - as well as Registrars of Voters offices all over the state. They will be making note if vans of voters get dropped off and come in and vote. They will be contacting EIPNV's attorneys and authorities to make arrests on election day. They need volunteers, many volunteers, who will be trained. The work isn't long, but it is intense during early voting until election day is over.
