Discussion:

John Eppolito - could not make it today to CTL, but asked to let you know people are needed at the next School Board meeting Tues. March 12th 2 PM 425 East 9th St. Pretty sure there will be parents there who are angry about Digital Days (days off from students having to show up at school, but they are to get assignments on the internet and do the work). Joe Hart of KTVN has been going after the District, Traci Davis, and the board about many things; tons of comments on his Facebook page mostly trashing the District, the board, and Traci.

Stay tuned to this spot where John will let folks know what to talk about on March 12th.

Basically, for over two years we've been asking the District to educate parents on all aspects of "free" third party EdTech vendor products then let them decide if their children will use these products or not. Currently the District makes the decision for parents. Not only will the District not educate parents, they won't tell parents when: there is a data breach and their children's information is placed for sale on the dark web, when their children's data is sold to the Chinese, or when the FBI puts out a Public Service Announcement warning parents and districts about EdTech vendors. The free third party vendors that do not have a contract with the District are the most problematic, i.e. the Edmodos of the world. Here's why: the

District and parents do not know what data is collected, stored, shared, and analyzed, by all these vendors. Many of these vendors state in their privacy policies or terms of service agreements they share student data with others, we do not know who these "others" are. Some of these vendors create profiles on students; neither the District or parents will ever see these student profiles. Experts do not know how all this student data in the hands of known and unknown parties, and the student profiles they create, will affect the future of our children. It appears some of these EdTech vendors will never delete student data, or student profiles. Now that the Chinese (via Edmodo) have an incredible amount of student data there is no way to control what will be done in the future with student data and student profiles. For the record, Edmodo (the Chinese) have data on over 77 million children.

Once educated on all aspects of third party vendors parents should get to decide if their children use them or not, currently the District is deciding for parents! Andrew was able delay revisions to Board Policy for clarification. The EdTech vendors discussed in the board policy are the ones the District has a contract with (i.e. pay), not the free ones. The revised language for the board policy should also be available by the March 12th meeting.

Andrew Caudill, School Board Trustee - March 12 is going to be a very busy meeting. Digital Days were approved by the NV Dept of Ed, way back from June, 2017 to June, 2020, as a way to have "snow days" that would not tack on to the end of the school year in June. But teachers would put the assignments online and students would still have to do the work, even if they weren't in school. So the media frenzy about unapproved Digital Days is not true. Works great if every single student had wi-fi or smart phones, but that is not the case.

Galena HS has had the Principal and Vice-Principal on paid administrative leave for a couple of months and now both have resigned, but the District is very hush-hush about it. Now the football coach has also resigned. These are personnel issues and cannot be discussed. The paid leave is basically the due process of

the employee(s), without which there would be lawsuits. Or if the employee(s) would be allowed to continue working, an accurate investigation would be impaired. This way, the investigation can happen while the employee is not present on the school grounds. If the investigation reveals wrong-doing, the paid leave will stop.

In 2006, WCSD decided on a shared governance model, with the Superintendent making the decisions, but the rest of the Board would evaluate the Superintendent. Superintendent Traci Davis is currently on contract, not set to expire until 2021 and they are evaluating her. It is considered a better way to keep her on task, doing her job than to fire her and pay her for not working, while needing to find and pay another Superintendent.

Vin Keenan - talked about the excellent nomination and confirmation of William Barr as Atty General. He seems to be one to want to move things along (like the Mueller investigation). Please consider contacting William Barr's Justice Dept and congratulating him on his confirmation and raising the prospect of a new Special Prosecutor to investigate the current special prosecutor. After all, Mueller was FBI Director when the Clintons were selling Uranium to Russia and Rod Rosenstein was also on the scene as US Attorney for the District of Maryland.
