From Dana Allen, Researcher - COVID 19 Treatment Research Collage

USA researchers did a double blind placebo test with **Hydroxychloroquine** a 70 year old anti-malarial generic drug that has been used by millions. The results **of 30 people with COVID 19 is of 15 on placebo 0% were cured, of 15 on Hydroxychloroquine 100% were cured** and no longer would infect others. It costs \$.70/pill in USA, \$.04 a pill overseas and the recommended treatment is 1 pill for 7-10 days so entire treatment is \$7.00.

This is wonderful news for poor countries. It is an extremely common drug produced in high quantities. It does have side effects but they are much more likely after years of use, for 7-10 days drug interactions would be the main concern. My sister used it several times for travel to tropical areas and recalls no side effects.

This is what is being used in Korea which has a death rate 1/10th of Italy which does not appear to use it as the standard treatment. As the study above notes it has a vaccine like prophylactic effect too. They sum up why they think it works here: *To summarize, because chloroquine has a multitude of extra nitrogens, once it crosses the membrane and enters an organelle, the organelle is prevented from reaching a lower pH. The organelle's enzymes cannot work because the donor group will be a hydrogen ion, disabling the hydrolysis required for Coronavirus replication. This means that all kinds of events in the cell are incapable of performing optimally, including viral replication.*

Similar test and results in South Korea and France.

UK Daily mail reported yesterday Australian researchers claim two existing drugs could 'cure' COVID-19 after patients they tested responded 'very well' to treatment. <https://www.dailymail.co.uk/news/article-8115879/COVID-19-Australian-researchers-CURE-coronavirus.html> And again it involves Chloroquine and in this study Lopinavir/ritonavir, the anti-HIV drug.

Today NBC is reporting about it <https://www.nbcnews.com/health/health-news/here-are-some-existing-drugs-may-be-repurposed-treat-coronavirus-n1162021> **“Based on encouraging preliminary findings from a study in France”, Sanofi is looking at ways to collaborate and partner with health authorities investigating the use of hydroxychloroquine for the management of coronavirus.**

In summation in my opinion the very best results seem to be with hydroxychloroquine. In a double blind placebo test in USA it was 100% effective in 6 days, and is one of the least expensive drugs in the world used by millions over decades. It does require a prescription in USA and doctors can prescribe it and are. From Jeff Church (who couldn't be online today) - Los Angeles Sheriff forces gun stores to be close. In spite of the federal Vitter Amendment case law, LA Sheriff closes gun stores. In spite of the LA District Atty advising otherwise, he closed gun stores. This is dangerous!

Jeff wanted us also to know about Reno City Council budget being out, with a huge deficit. City is suggesting suspending labor contracts, which could end up costing the City more \$\$ in lawsuits and deferred paybacks (sick time, etc). This budget completely omits what it will cost to settle the North Valleys flooding lawsuit. What about if the Business Improvement District (BID), currently being litigated, is voided by the courts or the IRS? The budget is in deficit without these considerations and that is NOT GOOD.

Jeff's better plan would be to cut everyone's pay 10%, across the board which might force senior police and fire to retire, which is better than laying off more lower paid new folks. He also suggested opening two shuttered fire stations by simply changing the 4-person crew requirement to 3 persons, which is the requirement of Sparks, Truckee Meadows, etc.

John Jorgensen updated with the info that closing gun stores was tried in NC several

years ago at a time of a hurricane emergency and it was litigated and overturned and NC changed its law. There is a law on NV books against allowing the Governor to close gun stores in time of an emergency. NJ and PA Governors just tried this last week and it is purported that the PA Governor has backed off already, under threat of a suit that would go all the way to SCOTUS.

The Los Angeles Sheriff also backed off that decision today,
